DESCRIPTION OF BUILDING PRODUCT

KWC is a Swiss company with a 150 year history manufacturing tap & sanitary fixtures. As a result of business expansion they also supply KWC product which was formerly branded as Franke. Another subsidiary is [KWS DVS](#). For purposes of this BPIR, KWC Sanitaryware describes the following scope of products.

KWC sanitaryware supplied by MacDonald Industries Ltd comprising:

- stainless steel basins, washtroughs, urinals, combination toilet and basin, WC and fittings (including flushing componentry) necessary for their installation and ongoing functioning
- basins manufactured from Miranit. This is a composite material manufactured from 80% mineral materials such as marble powder, sandstone and quartz sand and then bonded together with an unsaturated polyester resin (20%), and
- WC and basins manufactured by KWS DVS associated fittings (including flushing componentry) necessary for their installation and ongoing performance. These fixtures are manufactured from a glass reinforced polyester (GRP). GRP material is a single skin configuration which has three different weaves of glass fibre to give the product a good internal structural integrity, this is then impregnated with polyester resin.

MacDonald Industries Ltd is certified to ISO 9001 & 14001 certification by BSI. The scope of both certifications cover import, distribution and design, manufacture, distribution of sanitary fixtures (tapware and sanitaryware).
