DESCRIPTION OF BUILDING PRODUCT

MacDonald Industries Ltd manufactures and supplies a range of sanitary fixtures water saving and control devices, and hard wearing facings associated with sanitaryware. They also supply the required fixings to enable installation and the ongoing performance of these sanitary fixtures.

For the purposes of this BPIR they are collectively referred to as sanitary fixtures.

MacDonald Industries Ltd sanitary fixtures are intended for use in situations where tamper-proof characteristics, water saving features, and reduced maintenance is required.

MacDonald Industries Ltd has been supplying sanitary fixtures to this market segment for more than 40 years. During that time the products have met all performance requirements with no evidence of systemic failure.

The company is certified to [ISO 9001 & 14001 certification](#) by BSI. The scope of both certifications cover import, distribution and design, manufacture, distribution of sanitary fixtures (tapware and sanitaryware).
